GENERAL INFORMATION

Insist 90 is a spreader adjuvant used to improve the effectiveness of agricultural pesticides such as, Herbicides, Insecticides, Fungicides and Miticides. Insist 90 is a nonionic surfactant.

DIRECTIONS FOR USE

Insist 90 recommendations varies as necessary to achieve a smooth uniform film. Use only the minimum amount to get the desired effect.

NOTE: When mixing liquids with other chemicals, all chemical labels should be read in their entirety to ensure both chemical compatibility and compatibility based on the pH.

Tree fruits, Nuts, Vineyards, Vine Crop and Field and Row Crops

Use for dilute full volume sprays: Use 8 to 16 fl. oz. per 100 gallons (moderate easy to wet plants).

RECOMMENDED USE RATES

HERBICIDES: Use 1 to 3 pints (16 to 48 fl. oz.) per 100 gallons of spray solution.

INSECTICIDES: Use 1/2 to 1 pint (8 to 16 fl. oz.) per 100 gallons of spray solution.

FUNGICIDES & ACARICIDES: Use 1/2 to 1 pint (8 to 16 fl. oz.) per 100 gallons of spray solution.

DEFOLIANTS & DESICCANTS: Use 1 to 4 pints (16 to 64 fl. oz.) per 100 gallons of spray solution.

ROADSIDE APPLICATION: Use 1 to 2 quarts (32 to 64 fl. oz.) per 100 gallons of spray solution.

STORAGE AND DISPOSAL:

DO NOT STORE PRODUCT BELOW 50° F. (10° C)
IF FROZEN, WARM TO ROOM TEMPERATURE
AND MIX VIGOROUSLY
