**4. FIRST AID MEASURES**

**Description of first aid measures**

## **5. FIREFIGHTING MEASURES**

**Suitable extinguishing media:** To extinguish combustible residues of this product use water fog, carbon dioxide, dry chemical or foam. Dry chemical fire extinguishers.
