District 6 Interstates 95, 75, 395, 195 and State Highway Asset Maintenance

PROJECT OVERVIEW



DBi Services provides comprehensive management, operations and asset maintenance of state roads in Miami-Dade County within FDOT District 6. This includes I-95 and I-75, as well as portions of I-395, A-1-A (MacArthur Causeway), SR-826 (Palmetto Expressway), SR-970 (Downtown Connector), I-195 (Julia Tuttle Causeway), SR-913 (Rickenbacker Causeway) and Golden Glades Interchange.

This project encompasses roadways, structures and facilities on 58 centerline miles, 411 lane miles of limited access and highly transited roadways in one of the busiest and most vibrant areas in the country with some sections of I-95 carrying more than 242,000 vehicles per day. Also included are NBIS structure inspections and maintenance of all bridges, overhead sign structures and seawalls.

DBi Services has maintained this project since the second quarter of 2014. The contract runs for seven years with a one-time seven-year renewal option.

Project Highlights

DBi Services is responsible for accident and emergency response throughout the project corridor, including the implementation of One-Way Evacuation Operations in the event of a hurricane or other catastrophic event.

Also included in the project is maintenance and operations of the Express Lanes on I-95, as well as the lanes on I-75 and SR-826 upon completion. This work involves closing lanes weekly to perform maintenance on the lane separation system at night.

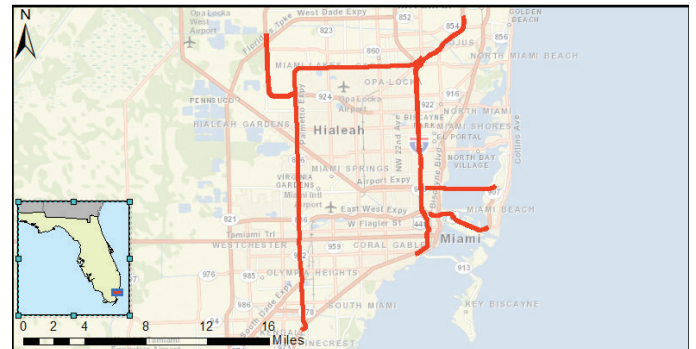
Because this area is a highly traveled tourist destination, DBi Services has been tasked with high standards for mowing and litter and graffiti removal. As a result, we increased the mowing cycles to 12 times a year, added an additional litter cycle and increased patrolling on known graffiti-prone areas.

Relevant Experience Gained

- The contract required DBi Services to mobilize within six weeks of NTP for this sizeable project. This involved reassigning and relocating 17 technicians and office staff, as well as bringing in six crew trucks, one bucket truck and two TMA trucks and establishing and equipping an area office. This required complex planning and execution and was completed with two days to spare.

Value to Customer

- Bundled operations and maintenance minimizing the number of contractors and streamlining the oversight needed.
- In-house services, such as landscaping, herbicides and the cleaning and coating of soundwalls, allow direct control of costs and quality.
- DBi Services had a significant leadership role on the FDOT/FHP One-Way Evacuation planning, and we are responsible for significant practical improvements to the plan and its implementation.
- DBi Services will be the first contractor in the State of Florida to perform NBIS structure inspections of all seawalls within the project area. DBi Services is currently developing the inspection criteria and reporting regime for this new responsibility.
